

## \$5,000

Supports onsite, free legal clinics at a local VA Hospital; this clinic serves close to 60 low-income and homeless Veterans who have medical issues.

## \$2,500

## 2014-2020

- Over \$2.5 million dollars in Veteran benefits and \$500K dollars in civil claims awarded to low-income VLI Veteran clients
- Approximately **200** lawyers and law firms have volunteered to serve the VLI mission
- The number of pro bono clinic dates has increased by **500%**, from 10 per year in 2014 to over 60 per year in 2020
- 17% of VLI clients to date have disclosed they have no income
- Over **50%** of VLI's clientele has a household income of under \$2000 per month

In 2020, 17 of 19 unlawful detainer cases avoided eviction and Veteran homelessness—roughly a 90% success rate versus a 60% or lower success rate per studies for those without representation.

In 2020, 83% of discharge upgrade decisions received by VLI were successful—that's 3.5x higher than average rate of success. Favorable upgrades resulted in low-income Veterans restoring their dignity and ability to access safe housing, healthcare, economic and other benefits.
