



In 2021, VLI managed over 2,200 active cases and recovered over \$1.3 million dollars in civilian monetary benefits. Cases continued to be complicated in all practice areas and included, eviction protections, family law, estate planning, connecting to veterans benefits, discharge upgrades, and more. Whenever possible, VLI has used a model of hybrid remote free legal aid in order to help veterans overcome the increasing anxiety, confusion, and isolation caused by the pandemic. VLI continued to provide free legal aid with staff and volunteers proactively reaching out using telephone, email, postal mail and zoom. VLI also leveraged over 60 virtual clinics with six strategic clinic partners across the Counties of Orange, Los Angeles, San Bernardino, and Riverside. Free legal aid included advice and counsel, negotiating with opposing parties, representation, document preparation and more.




